It must be ensured while receiving sample for testing that e-mail id of concerned office is mentioned in the forwarding letter, else the sample shall not be accepted for testing.
- 3. Test results / reports shall be submitted / conveyed by the laboratory within time period promised for completing each test through email and physical means. PDF format of the test report should be sent on the official email id(s) of the concerned office on the date of issue of test report as well as hard copy in original to the Engineer-in-Charge of the work and contractor.
- 4. This approval does not make the firm eligible either for claiming any right to get testing done through them only or for including their name in the tender documents.
- 5. Approval of the lab may be withdrawn prematurely in the event of complaints / fraudulent activity / undesirable action or on any other account without assigning any reasons.
- 6. CPWD reserves the right to witness the tests process to be carried out in laboratory as and when required. No extra charges shall be claimed by the lab for witnessing the test.
- 7. Logo of NABL/BIS should be printed on all test reports issued by the laboratory.
- 8. The approval shall be applicable to the works under Project Region Delhi only.

9. The "Stellar Test House" shall have valid calibrations certificates from NABL/BIS at all time.

10. The "Stellar Test House" Shall ensure the compliance of undertaking given by Shri Ankit

 - d. The approval does not absolve the supervisory officers of CPWD of their responsibility regarding Quality of work.
 - e. Performance of the Laboratory may be watched by field units and report be sent to this office prior to expiry of validity of this approval for considering further extension of approval.
