OFFICE MEMORANDUM



M/s STELLAR TEST HOUSE, G-68, Sector-63, Noida, U.P. - 201301 (INDIA), NABL accredited laboratory, is hereby approved and revalidated for testing of Building & Road construction materials as per the scope of NABL Accreditation for works under the jurisdiction of SDG (PRND) for a period of **2 (Two) years** from the date of issue of this letter, subject to following conditions:

1. Continued renewal of validity of NABL accreditation.
2. The approval/revalidation will automatically lapse after the expiry of this period unless got renewed.
3. Approval/revalidation can be withdrawn prematurely without assigning any reason on the basis of the complaints or uncalled-for action by the lab.
4. The approval/revalidation does not absolve the supervisory officer of CPWD of their responsibility of ensuring quality of work.
5. The approval/revalidation does not make the firm eligible for claiming the right to get the work done through them which is subject to their competitive stand amongst other qualifying specialized firm in the field to avail material testing facilities.
6. The performance of the firm shall be monitored by the field units and performance report shall be submitted to the approving authority before expiry of validity of approval/revalidation.
7. The field units shall be allowed to witness the testing, if so, required by them.
8. The laboratory shall retain the material after testing for at least 30 days from the date of report sent to the department.
9. On receiving of samples, the lab shall perform the tests within prescribed period as per CPWD specifications/BIS or other relevant codes/standards and shall submit the test results/reports within three days of conducting the test.
10. The lab shall report the acknowledgment of receipt of sample on same day via e-mail at official email ID of concerned AE/EE/SE/CE and contractor. Soft copy of the Test Report in PDF format shall be sent to the official email IDs of the concerned officers on the date of issue of Test Report as well as hard copy in original to the Engineer-in-Charge of the work and contractor.

11. The lab is liable to be debarred for a minimum period of one year in case any adverse remarks are received against the laboratory or repeated delays in issue of test reports for more than 7 days, are reported by the Executive Engineer to the approving authority.
12. This approval/revalidation shall be applicable within the jurisdiction of Special DG (PRND), CPWD, New Delhi only.
13. M/s STELLAR TEST HOUSE, G-68, Sector-63, Noida, U.P. - 201301 (INDIA), shall have valid calibration certificates of equipment/machines from NABL approved authority during the period of this approval/revalidation.
